To achieve certification, it must be a "financing entity", that is, in the business of making loans. The target market for the Organization is small business owners who have not had access to capital provided by traditional financing institutions such as banks, savings & loans, and credit unions. To achieve status as a financing entity, McCIF began making loans on November 3, 2020, and made a total of four loans in November and December of 2020 in the total amount of \$25,500. The revenue shown above represents interest on those loans collected during 2020. The lending program is McCIF's
