McLennan Community Investment Fund (McCIF) is a financing entity that has applied to the Community Development Financial Institutions Fund of the U.S. Treasury Department for certification as a Community Development Financial Institution for the purpose of providing loans to small business owners who have not had access to capital provided by traditional financial institutions such as banks, savings and loans, and credit unions. Utilizing funds provided by CDFI Fund and local sources, McCIF began its loan program in November of 2020 and continued throughout 2021. The loan program is McCIF's only program activity.
